To create a basic P&L manually, take the following steps:
Gather necessary information about revenue and expenses (as noted above).

List your sales. ...
List your COGS.

Subtra ct COGS (Step 3) from gross revenue (Step 2). ...
List your expenses. ...
Subtract the expenses (Step 5) from your gross profit (Step 4).

List your expenses. ...
Subtract the expenses (Step 5) from your gross profit (Step 4).
